PRIVACY POLICY STATEMENT

UNIVERSIDAD POPULAR AUTÓNOMA DEL ESTADO DE PUEBLA FOUNDATION

I. INTRODUCTION

UNIVERSIDAD POPULAR AUTÓNOMA DEL ESTADO DE PUEBLA FOUNDATION, hereinafter "UPAEP FOUNDATION" is responsible for collecting, using and protecting the private information of applicants, students, alumni, researchers, teachers, employees, members of the Board of Trustees, suppliers, donors, scholarship students/interns, volunteers, events and website visitors (hereinafter "Individual" or "Individuals"). UPAEP FOUNDATION is committed to safeguarding and protecting the right to privacy of each Individual, regardless of their status.

This policy has been issued and reviewed by the UPAEP FOUNDATION's BOARD OF TRUSTEES and is applied by the EXECUTIVE TEAM and its purpose is to inform the Individual of private information about the collection, use and disclosure of their data. UPAEP FOUNDATION created this policy in accordance with the Generally Accepted Privacy Principles ("GAPP").

UPAEP FOUNDATION is committed to protecting the personal information of data subjects, even when such information has been transferred by third parties authorized to transfer it.

UPAEP FOUNDATION maintains a policy of non-discrimination of holders.

II. SECTOR TO WHICH THE DECLARATION IS ADDRESSED

This Declaration is addressed to applicants, students, alumni, researchers, teachers, employees, members of the Board of Trustees, suppliers, donors, interns/interns, volunteers, visitors to events and visitors to the website, as long as they are of legal age with legal capacity to acquire rights and enter into obligations, or to grant their consent to the processing of personal data. under applicable federal, state, or local law within the United States, or the holder's home country.

UPAEP FOUNDATION does not directly collect personal data from children; In the event that it is necessary, depending on the purposes of the information, to collect personal data from minors, UPAEP FOUNDATION will require the written consent of the guardian of said minor, and may apply any determination or measure at its discretion, in order to verify that the guardian has the capacity to act on behalf of the minor. The consent given by the tutor will be in accordance with this Policy.

UPAEP FOUNDATION may resolve at its sole discretion any request related to the personal data of minors, in strict adherence to the laws that regulate the protection of minors.

UPAEP FOUNDATION does not collect sensitive personal data, if necessary, it will obtain the consent of the Individual.

III. CONFIDENTIAL INFORMATION PROCESSED BY UPAEP FOUNDATION

UPAEP FOUNDATION collects and retains certain information of a private, non-public, confidential and/or proprietary nature, including:

- Personal information of applicants, students, alumni, researchers, faculty, employees, members of the Board of Trustees, vendors, donors, fellows/interns, volunteers, event visitors, and website visitors, including, but not limited to: identification data, biographical information, contact information, tax information, financial information, wealth information, academic information, employment information, medical history, and demographic information.

With respect to donors, in addition to the information already referred to, it may also process everything related to planned or charitable giving, including all electronic and telephone communications related to such donations.

The information will be used exclusively for the purposes for which it has been provided by the Individual, according to its nature.

- Financial, Business, and Marketing Information: all non-public information relevant to the financial and operational affairs of the UPAEP FOUNDATION, including, but not limited to, the fundraising practices, objectives, and achievements of the UPAEP FOUNDATION; investment practices; past, current and planned development campaigns and activities; current or planned operational methods and processes; and any specialized knowledge related to the above activities; Current and projected fundraising projections or other types of organizational projections, including financial studies, financial and fundraising plans, and software and software developed specifically for or by UPAEP FOUNDATION to carry out its activities.
- Electronic data, including, but not limited to: the Internet domain from which a visitor accesses the website; the IP address assigned to the visitor's computer; the visitor's location, based on the IP address; the type of browser the visitor uses; the date and time of the visit; the address of the website from which the visitor linked to www.upaepfoundation.org; content viewed during the visit; time spent on the site web.
- All non-public information relating to UPAEP FOUNDATION's affairs, regardless of how documented, and all material derived therefrom, such as notes, emails, correspondence, analyses, compilations, studies, and abstracts, whether prepared by or for UPAEP FOUNDATION, that contain or are based, in whole or in part, on any Confidential Information.

In any case, the information collected will be reasonably necessary to fulfil the purposes. Under no circumstances will the information be used for purposes not informed and not consented to by the Individual.

IV. PURPOSES

UPAEP FOUNDATION collects personal data for the following purposes, depending on the nature of the Individual:

- **APPLICANTS, STUDENTS AND ALUMNI.** Personal information is used to identify, locate and contact the holders of the personal data, as well as to integrate, operate and manage their academic record, provide educational services, as well as manage scholarships for the benefit of the holder, carry out administrative procedures within the Foundation or before the corresponding Authorities or Dependencies. In some cases, UPAEP FOUNDATION will collect medical information, which will be treated in accordance with applicable state and federal privacy regulations
- **RESEARCHERS.** Personal information is used to identify, locate and contact the holders of personal data, as well as to integrate, operate and manage their professional file, carry out administrative procedures, make payment for services, as well as calculate taxes. In some cases, UPAEP FOUNDATION will collect medical information, which will be treated in accordance with applicable state and federal privacy regulations.
At the same time, researchers may collect information to carry out research studies, upon request for authorization from the UPAEP FOUNDATION, and always adhering to this Declaration. Information collected for research purposes may in some cases include responses to interviews and surveys. The information will be kept for the duration of the project in question and may be kept indefinitely by UPAEP FOUNDATION for purposes of public interest, scientific or historical research or for statistical purposes.
- **TEACHERS.** Personal information is used to identify, locate and contact the holders of personal data, as well as to integrate, operate and manage their work or professional file, carry out administrative procedures within the Foundation or before the corresponding Authorities or Dependencies, make the payment of services, as well as the calculation of taxes. In some cases, UPAEP FOUNDATION will collect medical information, which will be treated in accordance with applicable state and federal privacy regulations.
- **EMPLOYEES.** Personal information is used to identify, locate and contact the holders of the personal data, as well as to integrate, operate and manage their employment file, carry out administrative procedures within the Foundation or before the corresponding Authorities or Dependencies, make the payment of salaries, as well as the calculation of taxes. In some cases, UPAEP FOUNDATION will collect medical information, which will be treated in accordance with applicable state and federal privacy regulations.
- **MEMBERS OF THE BOARD OF TRUSTEES.** Personal information is used to identify, locate, and contact the holders of personal data.
- **SUPPLIERS.** Personal information is used to identify, locate and contact the holders of personal data, as well as to contract services and manage payments.
- **DONORS.** Personal information is used to identify, locate and contact the holders of personal data, as well as to manage all matters related to donations and send the corresponding receipts.
- **INTERNS and VOLUNTEERS.** Personal information is used according to the purpose of each project.
- **EVENT VISITORS.** Personal information is used to register and register attendance at events, inside or outside the UPAEP FOUNDATION facilities, as well as to generate the

corresponding recognitions. In general, personal information is used according to the purpose of the event.

UPAEP FOUNDATION has a video surveillance system that allows it to collect images and sounds in and around its facilities for security reasons of its facilities and property, as well as its visitors; to control access to your premises; to prevent or investigate unauthorized physical access that may or may not result in crimes or violations. In exceptional situations, the information collected may be shared with local authorities, as part of formal disciplinary or criminal investigations.

In addition, UPAEP FOUNDATION records videos and takes photographs of the events it organizes. UPAEP FOUNDATION generates and shares material through the website and social networks or other means for marketing purposes, in which images and sounds collected during the events may appear, in some cases, this material may be shared on the website of UNIVERSIDAD POPULAR AUTÓNOMA DEL ESTADO DE PUEBLA, A. C. (UPAEP for its acronym in Spanish).

- VISITORS TO THE WEBSITE. UPAEP FOUNDATION does not collect personal data through the website; The electronic data collected automatically allows UPAEP FOUNDATION to provide an optimal experience to the Individual when browsing the site.

And in general, UPAEP FOUNDATION uses personal information exclusively to comply with the commitments and obligations acquired from the relationship generated between the Individual and UPAEP FOUNDATION; and may be kept for as long as the Individual or Resident Individual (as explained below), is in contact with UPAEP FOUNDATION or for the time necessary to fulfill the purposes for which the information was collected, unless otherwise provided by Law.

UPAEP FOUNDATION may also use the information for the following purposes:

- a) Carry out any activity related to charitable, educational and scientific purposes.
- b) Promote the scientific, technological, cultural and athletic advancement of students and the community supported by the Foundation's programs.
- c) To promote, through research and scientific studies, academic excellence.
- d) Operate and provide the services of UPAEP FOUNDATION.

V. MEANS OF GATHERING INFORMATION

UPAEP FOUNDATION receives information from a variety of sources, including, but not limited to:

- I. The information that the Individual provides directly to UPAEP FOUNDATION;
- II. The information that the Individual provides directly to UPAEP;
- III. Information collected through your website (provided automatically or through automatic collection as detailed in the "WEBSITE AND USE OF COOKIES" Section);
- IV. Information lawfully obtained from third parties;
- V. Information collected by researchers, members of the Board of Trustees, employees or members of UPAEP FOUNDATION and/or UPAEP.
- VI. Publicly accessible sources.

UPAEP FOUNDATION receives and exchanges confidential information with UPAEP, in turn, it also generates its own confidential information.

UPAEP FOUNDATION maintains its efforts to preserve and update confidential information, regardless of its origin.

The information will be kept for the minimum period allowed by law in order to comply with the purposes for which it was collected. Once the term has expired, or at the request of the Individual, UPAEP FOUNDATION is responsible for eliminating and destroying the confidential information, establishing reasonable measures that allow its total destruction and prevent unauthorized access.

VI. VOLUNTARY DISCLOSURES

UPAEP FOUNDATION stimulates communication and trust with the Individuals of the information, which is why it voluntarily publishes the following information:

- Annual report.
- Mission and vision statements.
- Names of members of the Board of Trustees and staff.
- Administrative Policies and Procedures.

In addition, UPAEP FOUNDATION is required to disclose:

- IRS Form 990-PF_(no annexes).
- IRS Form 1023 (501(c)(3) letter)
- Articles of Incorporation

Any information not found on the UPAEP Foundation's website must be directly requested to **giving@upaepfoundation.org**

VII. TRANSFER OF INFORMATION

UPAEP FOUNDATION will, in some cases, transfer confidential information (including personal information) to UPAEP, we invite you to see the Spanish version of UPAEP's Privacy Notice . Confidential information may also be shared with other foundations, donors, institutions or authorities. The purpose of the transfer will be to discuss, approve or cancel the allocation of scholarships to students who request it and to provide accountability for the funds raised.

Confidential information is stored and processed in the United States and may be processed in any other country from which UPAEP FOUNDATION's service providers operate, provided that such transfer is necessary to provide a good or service or for security and fraud detection reasons.

By providing information directly to UPAEP FOUNDATION, by any of the means that permit it, the Individual consents to the transfer of his/her personal information outside of his/her country/region to the United States. All transfers are carried out in strict compliance with the

security measures established to preserve confidentiality and in compliance with the applicable legislation on the protection of Personal Data.

Except as contemplated in this Statement or as permitted by this Statement, UPAEP FOUNDATION does not sell or share confidential information with third parties for purposes other than those mentioned.

Notwithstanding the foregoing, confidential information may be made available to the members of the Board of Trustees, as well as UPAEP FOUNDATION staff, for the following internal uses: managing the history of donations or donors, processing donations, requesting donations, decision-making, generation of statistics or reports, among others.

UPAEP FOUNDATION provides information about donations and funds to its members, without the need for a confidentiality agreement; In some cases, you may also be able to provide it to the following people:

- a. To the person authorized in writing, by the member of the Foundation, to receive such information.
- b. To the person who has the authority to receive such information, upon the death of the member of the Foundation.

UPAEP FOUNDATION may transfer personal information in the following cases:

- When consent is obtained from the Individual.
- In compliance with federal, state, or local laws or court orders.
- When necessary to respond to sudden public health incidents or to protect the life and health of people, or the safety of their property, under emergency conditions.
- When confidential information is required to develop strategies and submit grant proposals.
- In order to provide names and addresses of donors of memorial funds to family members.
- When the various departments or areas of UPAEP FOUNDATION require to know the information for the fulfillment of their obligations and functions.

Prior to carrying out the transfer, UPAEP FOUNDATION, will obtain the consent of the Individual through the corresponding Confidentiality Agreement, unless the transfer is provided for by Law.

UPAEP FOUNDATION collects the corresponding Confidentiality Agreements from its staff in order to protect the use and management of the confidential information to which they have access. In addition, UPAEP FOUNDATION takes the pertinent security measures, these measures help UPAEP FOUNDATION to safeguard the confidentiality of the information in its charge, avoiding unauthorized use, disclosure, access, destruction or modification.

VIII. EXECUTIVE TEAM

The EXECUTIVE TEAM (hereinafter "the TEAM") has the following functions:

- It is responsible for drawing up or revising all agreements and conventions related to this Declaration, as well as interpreting and updating it when required, prior presentation and authorization of the Board of Trustees.
- Resolves incidents and requests related to children's personal data.
- It is responsible for responding to and implementing requests made by Holders and Resident Holders (as defined in the Section "RESIDENTS OF THE EUROPEAN UNION, SWITZERLAND, UNITED KINGDOM AND PEOPLE'S REPUBLIC OF CHINA").
- It is responsible for making available to the Authority the information subject to public inspection.
- It assesses each case individually, in order to make decisions about the processing of personal data in strict adherence to the principle of privacy.
- Analyze and address claims against refusals issued by the Executive Team itself.

IX. DONATIONS

UPAEP FOUNDATION receives donations in the following ways:

- A. By means of a check that is deposited in the bank account of UPAEP FOUNDATION or in funds of associated Community Foundations.
- B. On the website, through a PayPal account for credit card payments, debit cards or donations from other PayPal accounts. The PayPal account is linked to the UPAEP FOUNDATION bank account, during the operation the name of the donor, donation amount, date and purpose are automatically collected. In case of requesting a donation receipt issued by UPAEP FOUNDATION, the holder provides name, address, telephone number, amount and date of the donation, by giving@upaepfoundation.org mail.
- C. On the website, through the trust account with the Communities Foundation of Oklahoma. Also, through the various fund accounts that UPAEP FOUNDATION has with the Communities Foundation of Oklahoma. You can view the Communities Foundation of Oklahoma's Privacy Policy directly on their website.

X. INCIDENT MANAGEMENT

UPAEP FOUNDATION is committed to safeguarding confidential information as well as to applying the necessary and urgent measures in order to prevent, address and cease any event or situation that puts at risk or affects the privacy of the holders of personal data.

XI. RIGHTS OF THE INDIVIDUALS

The holder may, at any time:

- Refuse the processing of your personal information by UPAEP FOUNDATION, in which case, UPAEP FOUNDATION may not be able to provide you with the services or information that the Individual requires.
- Request UPAEP FOUNDATION to inform you what personal information it processes, for what purposes, if it shares such information with third parties and for what purposes. The information requested, including the information contained on the website, will be provided in an electronic, portable, machine-readable and easily usable format for the

holder, free of charge for a maximum of 2 times per year. Where the request requires the reproduction of documents, the Executive Team will apply a reasonable reproduction fee per page; In no event shall the cost of the fare be higher than the actual cost.

- Update or correct your personal information when it is inaccurate or incomplete, it will be sufficient to inform UPAEP FOUNDATION of the information you need to update.
- Refuse to receive advertising or information from UPAEP FOUNDATION.
- Refuse to have UPAEP FOUNDATION process your personal information.
- Request that UPAEP FOUNDATION refrain from processing your personal data in the future, for legitimate reasons.
- Request that your data and data shared with third parties be deleted, as long as there is no legitimate reason to retain the information. UPAEP FOUNDATION will keep the personal data strictly necessary for archival purposes or other purposes permitted by Law; UPAEP FOUNDATION retains information for the purpose of establishing, defending or exercising its rights with respect to future claims initiated by the Individual or by any third party.
- Request UPAEP to deliver the data provided by the Data Controller on a portable and as far as technically possible, easily reusable media in a format that allows the Data Controller to transmit the data to another third party, without hindrance, when the processing is authorized by automated means.
- Request that your data not be used for targeted advertising or profiling purposes.

UPAEP FOUNDATION must notify third parties to whom it has transmitted personal information, regarding the requests of the Individuals so that, if appropriate, they also apply the determinations made by the Executive Team of UPAEP FOUNDATION.

The holder may file a complaint against the determination of the Executive Team, so that the Executive Team can re-analyze the request and make a decision. It will be sufficient for the Individual to file the complaint in the same way as the request, within 30 days of being notified of the response.

UPAEP FOUNDATION will inform the Individual of the response to the claim within 30 days of receiving the claim, which may be extended once for a maximum of 60 days, when the complexity of the request warrants it.

The rights of the holder are inalienable.

XII. RESIDENTS OF THE EUROPEAN UNION, SWITZERLAND, THE UNITED KINGDOM AND THE PEOPLE'S REPUBLIC OF CHINA

This section shall apply to data subjects located in certain countries, such as European Union countries (EU residents), Switzerland, the United Kingdom or the People's Republic of China, in compliance with the EU General Data Protection Regulation ("GDPR"), the Swiss Federal Data Protection Act, the UK General Data Protection Regulation and the Chinese Personal Data Protection Act, where UPAEP FOUNDATION is processing your personal information.

Holders who are resident in any of these countries (hereinafter referred to as "Resident Holders") shall have the same rights as holders outside of such countries. In addition, they will have the following rights:

- Right of Access. Resident Individuals will be able to access their personal data held by UPAEP FOUNDATION, as well as learn about this Declaration. Resident holders may request a copy of their information from UPAEP FOUNDATION, in some cases a small fee will be charged for this service.
- Right to Rectification. The Resident Data Subject shall have the right to rectify his/her personal data when it is inaccurate or incomplete.
- Right to erasure. The Resident Individual shall have the right at any time to request that his/her personal data be deleted, as long as there is no legitimate reason to keep the information. UPAEP FOUNDATION will retain personal data strictly necessary for archival or other lawful purposes; In some cases, financial information is retained for legal purposes, including compliance with tax obligations; Likewise, UPAEP FOUNDATION keeps information for the purpose of establishing, defending or exercising its rights with respect to future claims initiated by the Individual or by any third party.
- Right to Restrict Processing. The Resident Data Subject shall have the right to request that UPAEP FOUNDATION restrict the processing of his/her personal data for certain purposes or in specific situations.
- Right to Object. The Resident Individual shall have the right at any time and for legitimate reasons to oppose the processing of his/her data, including the sending of communications that may be considered marketing material.
- Right to Data Portability. The Resident Account Holder shall have the right to request UPAEP FOUNDATION to transfer his/her personal data to any other organization or person.
- Right to object to automated decision-making or profiling, where applicable.

XIII. CONTACT DETAILS AND ATTENTION TO REQUESTS

Holders and Resident holders must formulate their request clearly stating the purpose, by filling out the Privacy Rights Request Form; They must also prove their identity by means of an official document. All requests, comments, queries, notifications of incidents or doubts regarding issues related to privacy and/or personal data will be directed to:

After UPAEP FOUNDATION has authenticated the identity of the cardholder, it will have 30 days to respond to the request via email.

Applicable laws contain certain exceptions and limitations to each of these rights. If the request does not proceed, the Resident holder will be informed of the reasons.

UPAEP FOUNDATION will speed up the issues that require it.

XIV. AUTOMATED PROCESSES

UPAEP FOUNDATION does not use automated processes to obtain or analyze personal data.

XV. WEBSITE AND USE OF COOKIES

The purpose of this section is to provide information on the processing of information collected through the www.upaepfoundation.org website. Please read carefully before continuing to browse the website.

By visiting the Website and providing your personally identifiable information, you understand and consent to the collection, use, processing, transfer, and disclosure of your personally identifiable and non-personally identifiable data globally, including in the United States, in accordance with this Statement. Therefore, by visiting the Website and providing such information, the Individual consents to the transfer of such information across country borders, and the use, processing, and disclosure of such information across global locations. Unless you are subject to the General Data Protection Regulation, your consent will be deemed to include your consent to the transfer of personally identifiable or non-identifiable information to locations that may have different levels of privacy protection than in your own country.
